



**A**s do all members of society, service members have a moral and legal obligation to provide adequate and continuous support for their legal family members. The majority of service members live up to the support obligation without any problems. However, there are times when spouses or children do not receive adequate support. If the couple has failed to come to a support agreement or the service member fails to pay the agreed-upon support payment, what are the options?

**T**he Defense Finance and Accounting Service (DFAS) has suggested that contact be made with the service member's command regarding nonsupport of lawful dependents. Remind the command that the service member may lose his/her entitlement by failing to use the dependent Basic Allowance for Housing (BAH) to support those for whom it was intended.

**T**o receive payment directly from the Navy, **you must obtain a court order or an administrative order.**

**B**ecause of severe consequences to the family and service member, it is important to obtain assistance as soon as possible. The Legal Assistance Office can assist family members with complaints of nonsupport. Legal assistance is available on an appointment basis.

**Y**ou should be aware that the Legal Assistance office cannot represent you in court. You may, therefore, want to retain an attorney. Look for an attorney who specializes in divorce or family law and is familiar with the military pay and allowance system. For referral to a civilian attorney, call the Virginia Lawyer Referral Service at 1-800-552-7977 or Ex-Partners of Servicemembers for Equality (EXPOSE) at 499-5386/440-1589.

**M**ediation, a voluntary settlement process, is an alternative way to settle differences. Rather than experience a costly courtroom battle, you can control the decisions that affect your family, your finances, and your life with the assistance of a mediator — an impartial person who helps people in conflict make practical, informed decisions to resolve the issues before them. Call a Fleet and Family Support Center for a listing of mediation services.

**I**f court-ordered child or spousal support is past due by an amount equal to two months support, the custodial parent can enforce that order by obtaining a garnishment of the service member's pay (an involuntary allotment). In order for your withholding order to be processed, it must include the debtor's full legal name and Social Security Number. Also, please be sure to include your return address on any correspondence, not only on the mailing envelope. To do this, call or write:
